### Vendor Participation Rules

Activity Date: Saturday, June 27th, 2015, Shands' Park, Stony Creek, Virginia

1. Event Hours: Saturday, June 27, 2015, (12:00 noon to 8:00 p.m.)
2. The Event Committee has sole discretion to approve or reject an application. All items to be sold are subject to approval by the Event Committee
4. Food/Drink Concessions: Food Vendors may sell drinks and other food concessions; no alcohol is permitted to be sold.

Food Vendors must indicate all items to be sold on a legible menu to include prices for each item. Also the necessary permits must be acquired by vendor through the Health Dept.

5. Concessions Stands Requirements: All Vendors are responsible for setting up and cleaning their space at the end of their business transactions. Set-up starts on Saturday, June 1st prior to 12:00 noon with completion by 8:30 p.m. The vendor is responsible for set up, operation, maintaining, and dismantling of their booth or area of operation. The vendor shall maintain a clean and safe operation for the full duration of the event. The vendor shall clean up booth site and remove or dispose of trash properly.

It is the vendor's responsibility to acquire all necessary permits and to pay all necessary fees prior to and after the activity. All vendors are expected to comply with all federal, state and local laws, rules and regulations and shall have all appropriate licenses, permits and other required documentation in their possession prior to setting up.

6. No electricity is available to the vendors. Please contact the Event Committee Chairman if you wish to bring a generator.
7. Vendors must receive Event Committee prior approval for all items to be displayed or sold at the event. Display or the sales of unapproved items may be cause to dismiss vendor from event grounds with no refund given.
8. The Cross Bearers "Christian Jubilee" activity will be held rain or shine, but if weather conditions are extremely unfavorable, event officials must act in the best and safest interest of all. There is no rain date for the Event and no refunds will be made.
10. Vendors that are no-shows will receive no refund and may be barred from future events.

11. The Cross Bearers Event Committee, its representatives, its membership or the owners of Shands Park are not responsible for property damages or injuries incurred during the Event.

12. Vendor signature on the Reservation Form indicates acceptance of these participation rules.

13. No application will be processed without payment of a non-refundable registration fee. Vendor space is limited and will be filled on a first come first served basis.

14. By participating in this event the vendor agrees to indemnify and hold harmless the City of Stony Creek, the Cross Bearers MM, the Event Committee and their directors, members, sponsors, officers, agents, staff, park owners and employees from any and all liability for damage, County health code violations, injury, or loss to any person or goods for any reason. The vendor understands that he/she is an independent party and is solely responsible for their booth space and the lawful operation of the same. Vendor further understands that the Cross Bearers MM is only responsible for providing a place for said Vendor to set up and conduct their business.
